1. A request by Mark Anderson of McDonald Garden Market, LLC, applicant, and Poquoson Shopping Center, LLC, property owner, for a Conditional Use Permit to establish and operate a garden center/market on a .56 acre parcel located at 7 & 9 Little Florida Road, Poquoson Tax Map Parcel Nos. 27-1-110 & 111, Zoned B-2 (Business).
