

The Electoral Board for the City of Poquoson met on Tuesday, February 2, 2022 in the office of the General Registrar, 500 City Hall Avenue, Poquoson, Virginia.

Present were Robert Insley, Chairman, Taylor Bresnan, Vice Chairman, Lynn Pauls who was appointed to the Board on 01/01/2022, Tammi Pinckney, General Registrar and Director of Elections and Tara Moore, Assistant Registrar.

Chairman Insley called the meeting to order at 2:03 p.m.

Tammi reminded the Board that the first order of business is to re-organize the Board.

Vice Chairman Bresnan made the motion that she serve as Chairman, Robert Insley serve as Vice Chairman and that Lynn Pauls serve as Secretary of the Board.

The motion was seconded by Chairman Insley.

Tammi provided the new redistricting maps for Poquoson. Poquoson is in Congressional District 001 (formerly 002), Senate District 024 (formerly 003) and House of Delegates District 086 (formerly 091). Our street file will be updated to reflect these changes. The deadline to update our districts is March 21st. Voters will be mailed notification of this change once complete.

Tammi advised the Board that there will be a meeting tomorrow, 02/03/22, with Assura and the City Manager's office to discuss the minimum security standards progress.

Secretary Pauls was given an overview of the minimum security standards and the on-going process by the City of Poquoson to meet these standards. Tammi will update the Board by phone after the call.

Tammi was notified by our vendor on January 31st that our current operating system, Windows 7, must be updated to Windows 10 on our voting equipment before the November 8, 2022 General Election. Windows 7 will no longer be supported by ELECT after 07/01/2022. Tammi was notified when our vendor discovered that he failed to notify Poquoson when other localities were notified in August, 2021. Because of the delay in notification this item was not included in our FY2023 budget. Tammi has advised the Finance Director, Leigh Ethridge. The budget submissions are still going through the approval process and Leigh and Assistant City Manager, Tonya O'Connell, will discuss what adjustments can be made on our FY2023 budget to include this item.

The cost to make the upgrade is \$1,600.00

After discussion of the list of Election officials Chairman Bresnan moved to approve the list. The motion was carried unanimously. Tara Moore will mail the Notices of Appointment.
