I have had explained to me the nature of the activity in which I am or my child is being enrolled. I understand that there are certain risks associated with this activity & that it is the duty of each participant to exercise reasonable care for his own safety and that of other participants.

If this consent is given for my child, I also understand that, while participating in the activity, my child will be expected to behave in a reasonable and responsible manner and that the activity's supervisory staff have the authority to discipline my child in a manner similar to that imposed in Poquoson City's public schools.

I also understand that general first aid, or medical care will be provided if necessary, and should an emergency arise, City of Poquoson staff, volunteers, coaches, reserve the right to secure emergency care for my child.

While it has been explained to me that the City of Poquoson prides itself upon the competency and dedication of its staff, I understand that, under Virginia law, both the City of Poquoson and its employees, its officers, and agents are immune from liability for negligence should I or my child suffer any injury while participating in the activity and that I may consider procuring insurance to protect myself or my child from such occurrences. With all of this in mind, I hereby give my consent to enroll me or my child in the activity listed above, specifically agreeing and consenting to the following where applicable:

- (1). I agree to allow photographic images of myself (my child) to be taken and utilized for promotional purposes by the City of Poquoson
- (2). I agree to allow myself or my child to be transported from the publicly advertised pick-up site to participate in the activity(s) listed above at the site identified in the activity information should it be required as described in the program.
- (3). I will be responsible for the payment of fees imposed by the City and the Barracuda Booster Club for the activity(s) I am registering.
- (4). I agree that I will and my child will behave in a sportsmanlike manner, and will not harass, or behave in a negative manner towards any coaches, children, referees or those in attendance at any Parks and Recreation Activity that I or my child may be attending or participating in at any time. And, I further understand I can be removed for such occurrence at the discretion of PPR officials, to include myself, my child or those in attendance related to my child's attendance at any time for said behavior. (5) I agree for my phone, address, and email information, and child's birthday to be provided to coaches and/or instructors and the Swimtopia program to administer the swim team program as necessary as related to the program I am registering.

Barracuda Swim Team Expectations and Code of Conduct for Swimmers and Families.

By participating on the Poquoson Parks and Recreation Barracuda Swim Team Your swimmer(s) and your family agrees to the following:

Our Family will:

- Encourage our child and all children who are a part of the team in a positive manner.
- Encourage sportsmanship at all levels, within the team and our opponents.
- Remain in the spectator area during competitions unless working the meet.
- Understand that rules are made to protect me, and others to make activities safe, and successful.
- Follow the expectations of the Parent Booster Club, and will work the required meets.
- Keep our emotions under control.
- Not verbally threaten or attack the coach, meet officials, or any other parent, on our team, or within any team in GPSA.
- Not use profanity, abusive language, harassing, or derogatory behavior while in attendance at any swim team function.
- Follow all pool rules at all facilities.
- Follow instructions from all lifeguards, coaches, and aquatic staff as directed at any swimming facility and during my participation in any swim team activity
- Be in good standing with GPSA and follow all league rules in place thru GPSA.
- Agree to abide by the rules set forth in Part III of the GPSA Code of Conduct & Acknowledge that, should we violate any provision of Part III, your swimmer and your family will be subject to disciplinary actions as set forth in Part IV.

I understand I will Provide volunteer service as required and detailed within the Barracuda Registration packet. And I understand that failure to comply with good standing in the Barracuda Booster Club will result in not allowing future participation for your swimmer until these matters are resolved.

During Swim Practice or Swim meets, I will:

- Support the coach and let him/her coach my child during the activities.
- Understand that my swimmer will not be allowed to enter the water until instructed by coaching staff.
- Understand my swimmer will exit the pool when directed.
- Not allow my swimmer or other family members to free swim during practice.
- Understand that my swimmer will swim the events as determined by Coaching Staff.
- Accept that the officials are doing the best job they can, and understand that many are volunteers. Will not harass or show bad sportsmanship towards any official, staff or opponent at any time, and follow all directions during the swim meets and practices.
- Respect all facilities and behave in an acceptable manner that will not lead to broken property or injury of me and others. No destruction of property permitted and can be cause for removal from the team.
- Respect all swimmers, all officials, coaches and other parents.

If My Behavior is deemed unacceptable, I understand:

- That I may be asked to leave the activities, and that my behavior as a parent or the behavior of my swimmer may result in being removed from the remaining sports season
- If I am involved in behavior that is not in accordance with good sportsmanship, with the GPSA Code of Conduct, or the policies set forth above, our family and myself, and my swimmer could be banned from any and all Parks and Recreation activities, and including any future activities involving my future children and to include participation in the GPSA SWIM LEAGUE now and for the future.
- All fees paid to Parks and Recreation are not pro-rated or refunded if a violation or offense occurs. The Season Pool Pass will also become null and void to the Poquoson Pool.
- All decisions related to such circumstances are final by City of Poquoson Staff.

Refund: After June 9, 2023 I understand there is no refund for this program.

2023 Parent Volunteer Agreement

Welcome to the Poquoson Barracuda summer swim team! In order for your swimmer(s) to participate on the swim team this summer, we MUST have 100% parent participation. The swim meets cannot happen without volunteers to run the many jobs that allow a smoothly run swim meet. Your commitment is EXTREMELY IMPORTANT!!

Each Swim Meet requires the following for volunteers:

- **Home Meets** –Minimum of 40 Volunteers needed at each meet
- **Charity Meet** – All parents/families must volunteer for your child to participate– does not count toward total shifts. We are the only team so EVERY JOB is our responsibility.
- **Away Meets** – Minimum 30 volunteers needed each meet

For 2023, we are asking each family to commit to working **8 - 10 shifts**. Exact number will be determined by how many families join our team following registration. ****Total number is dependent on families registered by June**** Average is generally closer to 7-8.

If your family does not meet the required shifts, your \$150 check, written at registration and postdated for **August 1, 2023** will be cashed.

_____ My volunteer service is *required* for my child to be a member of the team.

_____ I understand that I must make a good effort to work my shifts or I will forfeit my \$150 deposit. It is my responsibility to work my shifts around any vacations or missed meets. There will not be a refund of my deposit if I do not work required shifts.

_____ I may only sign up for one shift/per meet unless it has been approved by the Volunteer Coordinator or the PBBC Board. Some jobs do require 2 shifts such as the referee, starter, and scorekeeper.

_____ I understand I need to be at the pool no later than 5:30 pm for official/timers meeting (5:00 pm for concessions)

_____ I understand that I need to sign-up for the shift positions through Swimtopia or sign up genius. The sign-ups will be posted a few days before each meet through email. The signup will close by 8 pm the day before the meet.

_____ I will work my assigned positions or find my replacement for the job. I will then notify the Volunteer Coordinator of my replacement via email.

_____ I understand that I may be asked to fill in a job at a meet if I am not already signed up. There are times when we are short volunteers and will need to fill jobs in order to run the meet.

_____ I agree by serving as a volunteer, I release PPR, the Barracuda Swim Team, and the GPSA from any liability from my service as a volunteer and I do so at my own risk. By signing this, I am signing for anyone that is also working for my swimmer.
