For Democratic 350 Regular Ballots, 100 Absentee Ballots and 50 sample ballots will be ordered for each precinct.

The date for school of instructions prior to the Election was set for Wednesday, June 12 at 6:00PM, in Council Chambers.

After Discussion and review the lists of potential Election Official to work the dual Primary on June 18. Chairman Littlepage moved to approve list of Officials and the motion was carried unanimously. Deputy Registrar Moore will notify the individuals by mail.
