

The Electoral Board for the City of Poquoson met on Wednesday, August 20, 2025, in the office of the General Registrar, 500 City Hall Avenue, Poquoson Virginia. Present were Lewis Littlepage, Chairman; Jennifer Barnes Vice Chairman; Lynn Pauls, Secretary; Tammi Pinckney, General Registrar and Director of Elections and Tara Moore, Chief Deputy Registrar.

Chairperson Littlepage called the meeting to order at 2:08 PM.

The Registrar informed the Board that it is time to prepare for the upcoming November 4<sup>th</sup> Election and to determine the number of ballots needed, dates, times and locations for training; and to review the list of potential Election Officials. After some discussion all Board members agreed to the following:

- There will be 4,100 ballots ordered, for each precinct, for the November election.
- Electronic Pollbook training will be scheduled and Election Officials will be notified.
- School of Instructions will be Monday, October 20, 2025 in the large meeting room in the library. To accommodate Election officials who work full-time there will be two sessions offered on a first come, first served basis. The first is at 2:30pm and the second at 6:30pm.
